

This letter is response to the ORDER sent to me dated September 6, 2017 that extended the time for serving the record on appeal on the respondent to September 20, 2017.

I believe that there was a simple misunderstanding regarding the date (s) of the extension request because I asked for an extension of fourteen (14) days from the date that I actually received the additional transcript and instead I was granted an extension of fourteen (14) days from the date that the ORDER was processed which is today September 20, 2017.


As of today I have not yet received the additional transcript that I ordered from the court reporter on August 10, 2017 (proof of service was provided with the Motion for the extension) and according to Rule 207 of the South Carolina Appellate Court Rules the court reporter has until October 9, 2017 to deliver the transcript to me (60 days from when it was ordered).

Although I expect the additional transcript to be delivered by October 9, 2017; I will still need the fourteen additional days to prepare and serve the record on appeal on the respondent.

Therefore I respectfully request that the extension the time for serving the record on appeal on the respondent in the above referenced ORDER be amended to October 23, 2017 which would be fourteen days from October 9, 2017 and better fits the time frame allowed by Rule 207 of the South Carolina Appellate Court Rules for the court reporter to deliver the additional transcript.
