

I apologize that I do not have your phone number or email address and therefore am writing you this letter. The court has entered an order in this case that will necessitate that we receive a copy of the transcript.



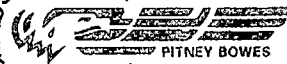
