MOTION TO FILE AND SERVE FINAL BRIEF AND RECORD ON APPEAL OUT OF TIME





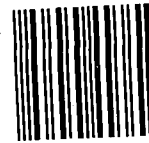
