

MOTION FOR EMAIL OR ELECTRONIC NOTIFICATION

Now comes David Lynd who hereby request the court have copies or notice of the response brief and any other filings either sent electronically by email or some form of notice of a filing sent by email. 

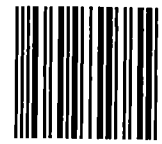
