

Dear Ms. Kitchings

I am responding to the Court's letter dated September 22, 2017. I did not include the date I received notice of the order in the notice of appeal as the notice of appeal was served within thirty days of the date of the order's entry. The date I received notice is therefore not necessary to determine the timeliness of the notice and therefore not required to be included in the content of the notice of appeal. This is my understanding of Rule 203 as to content of the notice of appeal which provides in part: "The date of the order, judgment, or sentence from which the appeal is taken; *and if appropriate for the determination of the timeliness of the appeal*, a statement of when the appealing party received notice of the order or judgment from which the appeal is taken, or, if a cross-appeal, when the respondent received appellant's notice of appeal." The date notice of entry is superfluous when the notice is served within thirty days of the entry of the order. If my interpretation of the rule is incorrect please let me know.

Also, as I understand, you did receive the check and it was in the correct amount. If you need me to do anything in regards to the notice please let me know.

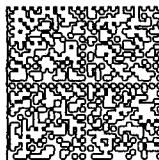
