4/2/2014: The court issues its order setting this case for date-certain trial to commence 11/3/2014.

- 4/29/2014: The court issued an Amended Scheduling Order. This Amended Scheduling Order rescinded the order setting of this case for date-certain trial commencing 11/3/2014.

- 1/12/2015: Respondent files Motion to Unseal Ex Parte Funding Requests.
- 1/22/2015: Respondent files Motion to Take Depositions.
- 2/24/2015: Applicant files Motion for Summary Judgment.
Applicant files Motion *In Limine*.
- 2/27/2015: By Form 4 order, Applicant's Motion For Continuance, Motion for Summary Judgment and Motion *In Limine* are denied without oral arguments.

By Form 4 order, Respondent's Motion to Unseal Ex Parte Funding Requests is granted without oral arguments.
- 3/2/2015 – 3/3/2015: Trial.
- 5/13/2016: Court issues Order Denying Post-Conviction Relief.
