
I request that you provide me with a portion of the transcript of the proceeding. Please transcribe the jury charges made by Judge Early only.

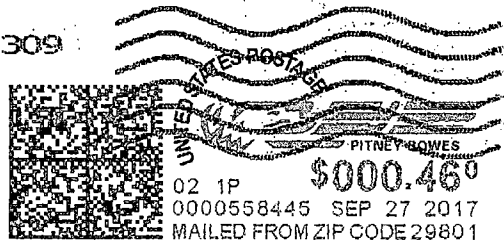
