**SECOND MOTION TO DISMISS APPEAL**

Respondent Randy L. Mills (hereafter "Mills") moves a second time to dismiss the appeal by Appellant Tom Efland (hereafter "Appellant"). In support of his motion, Mills will show:

1. This is an appeal from an order which granted Mills' Motion for Judgment on the Pleadings as to Appellant's claims in the underlying action.
2. The detailed history of inaction and delays by Appellant in this proceeding was detailed in Mills' first motion to dismiss dated June 29, 2017. Appellant did not even bother to respond to that first motion to dismiss, although this Court denied the same by order dated August 2, 2017.
3. Mills has confirmed with Court of Appeals staff that as of 3:00 PM today, Friday, September 29, 2017, Appellant's initial brief and designations have still not been filed by Appellant,

despite having been due<sup>1</sup> on September 25, 2017. Court of Appeals staff further advise that the last mail delivery of the day occurs on or before this time, confirming no such filing by mail will be made today by Appellant before close of business for the weekend.


4. Likewise, neither this Court nor the undersigned have received any request or motion for an extension of time.
5. Accordingly, Mills again seeks dismissal of this appeal for the latest failure by Appellant to comply with deadlines imposed the applicable rules.
6. In so doing, Mills incorporates his detailed exhibits and chronology submitted in his original motion to dismiss dated June 29, 2017.
7. In addition, Mills would note that when the Notice of Appeal was filed and served on the 31<sup>st</sup> day after the trial court's order was issued, Appellant did not file a copy of the Notice on the Richland County Clerk of Court as required. The Court reminded Appellant on May 17, 2017 that he had not provided proof of service on the Clerk of Court, and granted Appellant an additional ten days to remedy the defect in the notice of appeal.
8. As referenced above, Appellant filed no response to the initial Motion to Dismiss filed by Mills. While not required to be filed, a "response" is the only method provided by the rules to indicate opposition to a motion filed with the Court. Rule 240(e), SCACR. Thus when this Court denied Mills' motion to dismiss on August 2, 2017, it did so despite Appellant not putting forth any opposition to the motion.

<sup>1</sup> The due date is calculated pursuant to Rule 208(a)(1), SCACR which requires the filing of an initial brief within thirty days after receiving the transcript. C-track reflects a letter from Appellant's counsel indicating receipt of the transcript on August 24, 2017.

9. Appellant is five (5) days late with the filing of his Initial Brief and Designations (Rule 208(a)(1), SCACR), or requesting an extension of time to do so. Rule 263(b), SCACR.
10. It is anticipated that as soon as this motion is served via fax to Appellant's counsel today, this Court will either receive (1) an initial brief and designations with a COS indicating it was mailed on September 25, 2017, yet inexplicably delayed in the usual one-day mail service from West Columbia, or (2) a motion acknowledging the deadline was missed, yet requesting to file Appellant's initial brief and designations out of time.
11. Had this case, which has its origins in litigation that was filed initially in 2005, not been delayed so many times at the trial court level and now at the appellate level, Mills would have been more accommodating and patient for what appears to the sort of likely inattention to detail that is often excused by this Court. However, after twelve (12) years of missed deadlines, failure to appear/respond and repeated extensions of time, Mills respectfully requests that this appeal be dismissed.<sup>2</sup>
