**NOTICE OF APPEAL**

Ronald J. Berke appeals the Final Order (Ending Case) (the "Order", a copy of which is attached hereto) of Marvin H. Dukes, III dated August 30, 2017. The Order reversed a finding by Honorable Angela McCall-Tanner of the Beaufort County Magistrate Court (the "Magistrate Ruling"). The Magistrate Ruling, arising from a trial of the case before Judge McCall-Tanner on May 4, 2017, granted Appellant's petition to evict Respondent from a residence located on Hilton Head Island and also found for Appellant with respect to Respondent's Counterclaim. As the Circuit Court was ruling as an appellate court, neither of the parties had filed anything in the matter electronically and thus had not registered electronically as attorneys of record, and did not learn of the Order having been electronically filed until September 21, 2017, when counsel for both parties received a letter in the mail from the Circuit Court.



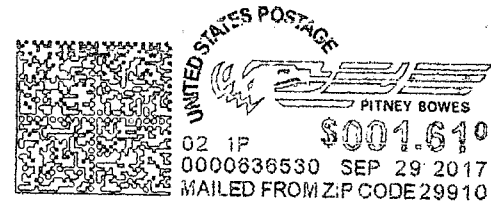
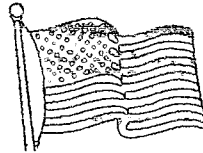
