AND NOW COMES Petitioner The Callawassie Island Members Club, Inc. (“Petitioner”) with the written consent of Respondents Ronnie D. Dennis and Jeanette Dennis (“Respondents”), pursuant to Rule 263(b) and Rule 240 of the South Carolina Appellate Court Rules, and respectfully move the Supreme Court for a fifteen (15) day extension of time to serve and file their brief and copies of the Appendix as required by Rule 242(i), SCACR, for the good cause as set forth below:

1. The Court granted Petitioner’s Petition for Writ of Certiorari by Order dated September 8, 2017.

2. Pursuant to Rule 242(i), SCACR, Petitioners’ brief and copies of the Appendix are due to be filed on or before Monday, October 9, 2017 (the thirtieth day falls on the preceding weekend).


3. Petitioner files this motion requesting an additional fifteen (15) day extension to file its brief and copies of the Appendix. Petitioner has obtained the written consent of counsel for Respondents to this request for an extension of time. Petitioner has not previously requested an extension of time from this Court in this appeal.

4. Petitioner has taken exception to two rulings from the Court of Appeals and requires the additional time to fully and adequately prepare its brief. Given this need and the intervening effects of Hurricane Irma between the time of the Court’s Order granting the Petition for Writ of Certiorari and the due date for Petitioner’s brief, Petitioner respectfully asks for this extension time to have sufficient time to prepare its brief and address all exceptions to the rulings from the Court of Appeals.

5. Petitioner has consulted with counsel of record for Respondents, and such counsel consents to Petitioner’s request for an extension of time. If the extension is granted, Petitioner’s brief and copies of the Appendix would need to served and filed on or before Tuesday, October 24, 2017.

Therefore, for the foregoing reasons and with the consent of counsel for the Respondents, Petitioner respectfully asks this Court to grant it an extension of time to file its brief and copies of the Appendix until October 24, 2017.
