**APPELLANT'S MOTION TO REVISE RECORD ON
APPEAL OF RESPONDENT TO DELETE
SUPURFLOUS DOCUMENTS AND PAGES**

Pursuant to Rules 209 and 210 of the South Carolina Rules of Appellate Procedure, Appellant geary-thomas: Dooly, the living man ("Appellant") makes special appearance to hereby move the Court for an Order for Respondent to remove all irrelevant documents, and pages from Respondent's "Designation of Matter to be included in the Record On Appeal".

On August 31, 2017 Respondent filed DESIGNATION OF MATTER TO BE INCLUDED IN RECORD ON APPEAL (see **EXHIBIT A**) which included 25 items of which many were irrelevant to this Appeal. Furthermore, most of the items included the phrase "and including all accompanying exhibits", wherein a vast majority of the "designation of matter" of respondent is irrelevant, superfluous, and will only serve to burden the court with several HUNDRED PAGES of irrelevant matter in that only a page or few pages from any referenced document is relevant to this appeal, NOT "and including all accompanying exhibits".

The discrepancies of the Designation of Matter by Respondent are far too numerous to detail herein, and Appellant should NOT dictate which pages of a particular document designated by Respondent should be included. It would only be just to allow the Respondent to delete all "irrelevant" pages of filings, and to "designate" only those pages needed by the court. To point out just one such blatant "designation": Item 7 of **Exhibit A** with "all accompanying exhibits" amounts to 111 pages, which begs the question: "Are all those 111 pages relevant or irrelevant to this appeal, and needed to be reviewed by the Court to decide the issues in this appeal?" Certainly NOT!

Therefore, for reasons stated above, Appellant respectfully request this Court issue an order requiring Respondent to edit out all irrelevant pages of Respondent's Designation of Matter to be include in Record On Appeal. This Motion is based on the filings in this case, and the South Carolina Rules of Appellate Procedure 209 and 210. Furthermore, the Order is requested to include an extension of time for Appellant to serve all parties, and to file Record On Appeal with the Court, once revised designation is submitted.
