MOTION FOR AN EXTENSION OF TIME



On September 22, 2017, counsel, along with co-counsel, filed the initial brief of appellant and designation of matter in The State v. Bennie Ray Brown, Jr. with this Court. On September 21, 2017, counsel filed the brief of petitioner in The State v. Roy Lee Jones with this Court. On September 20, 2017, counsel filed the petition for writ of certiorari and accompanying appendix in Brett Howard v. The State with this Court. On September 18, 2017, counsel filed the petition for writ of certiorari to the Court of Appeals and accompanying appendix in The State v. Wayland Purnell with this Court. On September 8, 2017, counsel filed the petition for writ of certiorari, accompanying appendix, and brief of appellant pursuant to White v. State in the case of Gregory Murphy v. State with this Court. On August 31, 2017, counsel filed the initial brief of appellant and designation of matter in The State v. Terrence Seabrook with the Court of Appeals. On August 23, 2017, counsel filed the petition for writ of certiorari and accompanying appendix in Andrew Blackmon v. The State with this Court.

4. Counsel makes this request in good faith and not for purpose of delay.


5. Counsel for the Attorney General's office consents to this request as shown by signature below.


