MOTION FOR A 30 DAY EXTENSION TO FILE THE RECORD ON APPEAL





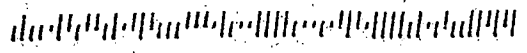
