PETITION FOR EXTENSION TO FILE

The undersigned counsel respectfully requests a thirty-day extension in which to file the petition for writ of certiorari from the Court of Appeals and accompanying appendix in the above-referenced case. In support of this motion, counsel would respectfully show the Court the following extraordinary circumstances:

Counsel is filing the petition for writ of certiorari in Michael Anthony Sarratt v. State also with this Court today, May 23, 2012. Counsel is also preparing the initial brief of appellant and designation of matter in State v. Roosevelt Reaves to be filed with the Court of Appeals on May 29, 2012. Counsel is preparing the petition for writ of certiorari in Allan Lee Hawkins v. State to be filed with this Court on May 30, 2012

3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.

WHEREFORE, the undersigned counsel would respectfully request a thirty day extension. Counsel respectfully requests that the time limits for filing the petition for writ of certiorari and accompanying appendix be held in abeyance pending a ruling on this motion.


