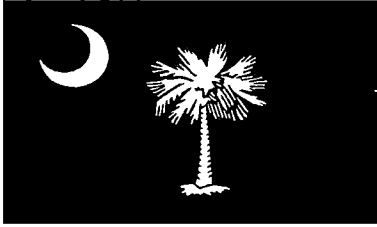


Dear Ms. Kitchings




