

1) The petition and appendix are due on October 5, 2017. This petition is Mr. Love's second request for an extension.



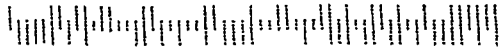
