Based on an investigation by the OCSO, the defendant Marvin Guest did violate section 16-25-20(B) 5 (E) of the SC Code of Laws, Domestic Violence First Degree. On June 27, 2017, one Marvin Guest did hit one Arielle Haynes about her head and body with his fist while her child was present.
