

Electronic Filing Is Coming to the Supreme Court

ACTION REQUIRED

Beginning November 13, 2017:

- While paper will remain the official filing, parties *represented by counsel* must also submit most documents through the electronic filing system.
- Parties representing themselves will not file electronically, but all public filings will be scanned and made available on the Court's website.
- Attorneys must obtain a username and password by registering through the website: <https://file.supremecourt.gov>.
 - It may take up to 2 business days to have an application approved, so plan in advance.
- The opening of registration will be announced on the Court's website in early October.

Rules, Requirements, and Resources

- Cert petitions and other case-initiating documents will be publicly available on the Court's website once the hard copy is received and approved for filing; subsequent submissions will be publicly available within minutes after submission.
- Guidelines for the submission of documents have been issued by the Clerk's Office: https://www.supremecourt.gov/filingandrules/rules_guidance.aspx.
- Electronic submission should be at or near the time the document is filed (i.e., delivered to the Court, placed in the mail, or delivered to a third-party carrier).
- New Supreme Court Rule 34.6 contains a number of new requirements designed to protect personal privacy. It largely adopts the rules applicable in the federal district courts:
 - Certain types of information is to be redacted from the paper and electronic versions of filings—social security numbers, financial account numbers, etc. See Fed. R. Civ. P. 5.2(a)
 - Filings in social security and immigration cases that were not available electronically in the lower courts are not to be filed electronically here. See Fed. R. Civ. P. 5.2(c).
