Dear Mr. Shearouse:

In response to your letter of October 4, 2017, I offer the following:

I took-over Mr. Walker-Wilson's representation in the above matter from my former law partner, George H. Hanlin, Esq., by order entered June 4, 2013.

The case was tried before the Honorable Diane S. Goodstein, on August 5, 2013. In an order entered January 28, 2015, entitled "Order Granting Post Conviction Relief," Judge Goodstein granted the request that Mr. Walker-Wilson's post-conviction relief application be heard on the merits, finding petitioner's application timely, but denied the post-conviction application on the merits.

On February 9, 2015, I filed, on my client's behalf, the Rule 59(e), motion to alter or amend Judge Goodstein's January 28, 2015, order. However, on February 3, 2015, the State filed a notice of appeal of Judge Goodstein's order. I received a copy of the notice of appeal on February 5, 2015.

On February 26, 2015, the South Carolina Supreme Court, at the State's request, dismissed the appeal.

By order entered July 20, 2016, Judge Goodstein denied the Rule 59(e) motion. I received a copy of this order on July 27, 2016.

By letter dated August 8, 2016, I forwarded a copy of Judge Goodstein's July 20, 2016, order to the South Carolina Commission on Indigent Defense, on the mistaken impression the Commission would proceed with any necessary or appropriate appellate process. I received no reply. I did not file a notice of appeal.


By letter dated February 3, 2017, I forwarded a second letter to the South Carolina Commission on Indigent Defense. I received no reply.
