

Applicant has moved this Court for an Order of Discovery to allow him to investigate and acquire records relating to issuance of a search warrant in his case. Applicant alleges that the records in the possession of the State would support his case for post conviction relief and that the Sheriff of Spartanburg County has refused to comply with a subpoena duces tecum issued for records relating to the Applicant's case.

After hearing the arguments by both Parties I find that the Applicant is entitled to an Order of Discovery to obtain records in the possession of the State, including the Sheriff of Spartanburg County or other law enforcement or State agencies involved in the investigation, search, arrest, or prosecution of the Applicant.
