
Dear Honorable Ms. Kitchings:

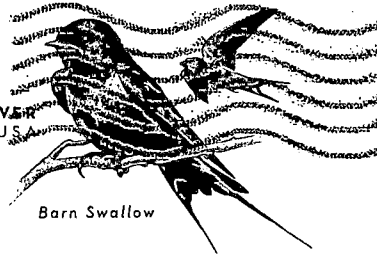
