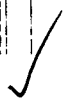

APPELLANT'S MOTION TO ENLARGE TIME TO FILE INITIAL REPLY BRIEF






