For the reason set forth herein, counsel for the Appellant submits that good cause has been shown why this matter should be dismissed.





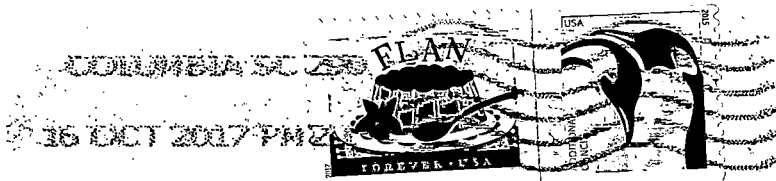
