

Major Donnard Dubose III appeals his conviction and sentence in this case. The sentence was imposed by the Honorable Thomas A. Russo on September 13, 2017.





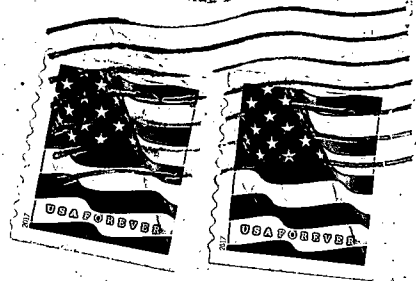
