




Honorable Jenny A. Kitchings,

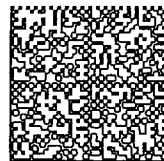
