**MOTION TO WITHDRAW THE APPEAL**



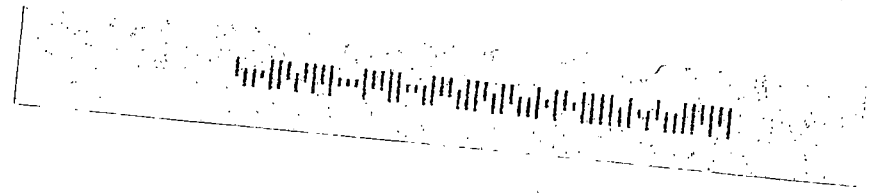
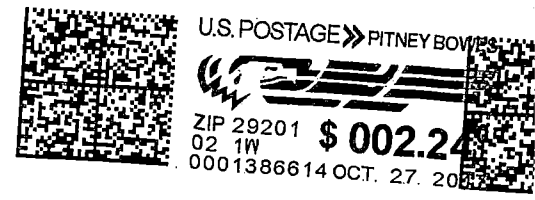
