

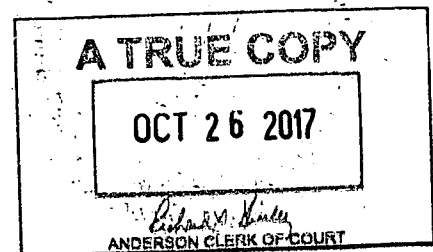
NOTICE OF APPEAL
