I also asked my lawyer for copies of my indictment several times and was never provided with these. I want these files so I could check the deficiencies of my indictments.

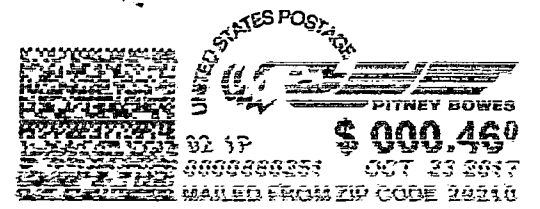
