Respondents respectfully move this court for an Order granting them an extension of time in which to file and serve their Brief.



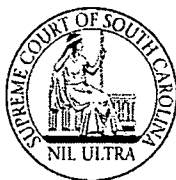
