
## ORDER

---

Appellant David C. Sojourner, Jr., in his capacity as Limited Special Administrator and Limited Special Trustee (LSA) has notified this court that LSA has reached a settlement with Respondent and seeks to withdraw its appeal. Appellants Deanna Brown-Thomas, Yamma Brown, and Venisha Brown filed a response, requesting that LSA's withdrawal be conditioned on: (1) LSA's brief and designation of matter being made part of the record, and (2) that LSA confirm and/or disclose all terms of the settlement agreement. LSA filed a reply, consenting to its brief being made part of the record, but refusing to disclose all terms of its settlement agreement.

After careful consideration, LSA's request to withdraw its appeal is granted. Because Appellants Michael Deon Brown and Daryl Brown have notified this court that they adopt LSA's briefs, the briefs and designations previously submitted by LSA will be before the court as the briefs of Michael Deon Brown and Daryl Brown. Appellants Deanna Brown-Thomas, Yamma Brown, and Venisha Brown's requests are otherwise denied.
