DEAR MR. SHEAROUSE:

PLEASE ALLOW MY CORRESPONDENCE TO SERVE AS MY RESPECTFUL NOTICE IN THE ISSUE OF MR. LANGLEY AND THE REPRESENTATION HE HAS EXPLAINED TO YOUR OFFICE ABOUT MY APPEAL CASE MATTER. WHILE MY ORDER OF DISMISSAL DATED 06/28/2012, MR. LANGLEY DID NOT FILE MY APPEAL WITHIN THE REQUIRED TIME TO DO SO, MR. LANGLEY INFORMED YOUR OFFICE THAT HE HAD MOVED AND THE FINAL ORDER WENT TO HIS OLD ADDRESS, OCTOBER 11, 2012, WAS THE DATE OF THIS LETTER HE WROTE TO YOUR OFFICE. IN THIS SAME LETTER HE WROTE TO YOUR OFFICE, MR. LANGLEY ALSO INFORMED YOU THAT HE WAS CURRENTLY IN THE PROCESS OF FILING A TIMELY APPEAL AND HELPING ME TO OBTAIN REPRESENTATION FROM THE APPELLATE DEFENSE DIVISION, etc.

ON JUNE 04, 2012, AT NEWBERRY COUNTY COURTHOUSE WHERE MY PCR HEARING TOOK PLACE, THEREAFTER THE HEARING MR. LANGLEY HAS NOT BEEN CONTACT WITH ME AT ANY TIME. I HAVE WROTE TO HIS OFFICE AND GOTTEN MY FAMILY MEMBERS TO CONTACT HIM AND I HAVE NOT RECEIVED ANY CORRESPONDENCE FROM MR. LANGLEY WITHIN THE LAST SIX (6) MONTHS. I DO NOT KNOW HOW MY APPEAL STANDS TO YOUR OFFICE AS I DID FILED IT PRO SE TO PREVENT ANY FURTHER SUFFERING ON MY PART CAUSED BY THE LAWYER, BUT WITH ALL DIE RESPECT MR. SHEAROUSE, MR. LANGLEY MAY GIVE AN DIFFERENT EXPLANATION AS TO HOW I STAND BUT HE CAN NOT GIVE FURTHER EXPLAINING AS TO WHY HE HAVE NOT ASSISTED ME IN THIS APPEAL TO BE PROPERLY FILED TO YOU RESPECTFUL OFFICE SIR. I HAVE DONE WHAT WAS APPROPRIATE AND THAT WHAT THE LAWS PERMITS ME TO DO, AND TO NO AVAIL HAS THE JUSTICE RINGS, NOWAS TO ME ZEST TO RECEIVE A REVIEW TO MY PCR DISMISSAL, PURSUANT TO THE PCR LAWS AS SC CODE ANN. § 17-27-90 AND RULE 71.1 (g), SCRPC, THE APPELLATE PROCESS OF MY APPEAL IS A MATTER OF LAW AS I AM ENTITLED TO ONE, etc. AND I ASK THIS HONORABLE COURT TO ATLEAST BE SPEEDILY TO HAVE MY CASE MATTER CORRECTED SO THE CASE COUNSEL WILL BE REMINDED ABOUT THE FACTS THAT HIS DUTIES OWED TO ME SHOULD NEVER TO OVERLOOKED AND THAT YOUR OFFICE AT NOT TIME IS TO BE MISLEAD AND OR TOLD FALSE STORIES TO, PLEASE HAVE MR. LANGLEY TO EXPLAIN WHY THE APPEAL HAVE NOT YET REGISTERED TO THE DIVISION OF APPELLATE DEFENSE.
