his work and he left his work at the meter
and Power Box not grounded as required for
safety to the home owner, and the home and
exposing very dangerous electrical wires and

The City Building Dept never inspected this electrical contractors construction because they stated Saldon Electric never called in his inspection.

Because Thomas Furiolo filed into the Court his case against the City of Greenville and in doing so once again the City closed all doors to inspect dangerous and unsafe conditions to the home owner and to his home.

I now accuse the City of Greenville with malice and to not inspect electrical conditions and remains an intentional act of malice.

The City Building Dept officials also as was they provided their permit to the electrical contractor clearly knowing he stated his electrical construction

took place by City inspectors.

My roof leaks in several rooms when it rains
and as it did before. The same rooms locations

what Mr Bristow did was to have his workers
lay shingles on top of each other to build up
the 12 new wood boards planks. roof on

my guess is the weight of roof shingle on top of each other caused the knee wall to bend or fall because of the weight. So, the roof structure is bent and you can see it looking esp. the sheathing up wood with shingles that very heavy may have destroyed the integrity of old wood. or something happened

In any case while LLR inspectors, investigators were here last week they took photographs of my roof they soon will be investigated so another complaint was filed against them. the roofing contractor. Allen Bristo.
