[PETITION FOR REHEARING

Petitioner Gregory L. Campbell respectfully petition for rehearing to be reheard on the decision of the Supreme Court of United States regarding the denial of the Petition for writ of Certiorari entered on the 10th day of October, 2017.

REASONS FOR GRANTING THE PETITION

After carefully reviewing the Petition for Writ for Certiorari, I Gregory L. Campbell the Petitioner felt that I could have been more precise in my reasoning for appeal from the Lower Courts of South Carolina; I Gregory L. Campbell the petitioner therefore wish to enter this Petition for rehearing listing more precisely the reason(s) for appeal from the lower courts of South Carolina as following:

Reason for appeal from the Court of Common Pleas of Georgetown S.C.:

According to SCRCP 4b, the defendant has 30 days to provide an answer to the filed Summons and Complaint or relief should be granted to me, Gregory L. Campbell the petitioner for the amount demanded in the complaint. The defendant failed to provide an answer within 30 days as required by this rule. When an answer was provided, after a motion for Summary Judgement stating the default was entered, the defendant claimed his tardiness was due to an interoffice error. The judge of the Lower Court of Common Pleas dismissed the Summary Judgement, according to SCRCP 55c stating that the defendant reasoning was solidified (good Cause). However, rule 55c only allow tardiness to the summons and complaint for an uncontrollable circumstances (good cause) such as natural disasters, death in the family, illness, ect.. Therefore,

I Gregory L. Campbell the petitioner appealed the decision of the Lower Court of Georgetown S.C..

Reason for appeal from the Court of Appeals of S.C.:


The South Carolina Court of Appeal dismissed the appeal claiming that it wasn't immediately appealable. I, Gregory L. Campbell, appealed this decision because it was immediately appealable after the Order to dismiss was entered, and the judge of the Court of Common Pleas had made his final decision as described in the transcript.

Reason for appeal from the Supreme Court of S. C.:

The Supreme Court of S.C. denied my appeal simply stating that I could have requested a rehearing or reinstatement. I Gregory L. Campbell the petitioner do agree with the Supreme Court of S.C. in that I could have requested a rehearing or reinstatement, however an appeal was also an option being that a final decision was made, an Order to Dismiss was signed, and the decision was remitted to the Court of Common Pleas of Georgetown S.C.. It is my constitutional right to appeal any final decision, and the Court of Appeal made a final decision and remitted it. Therefore, I, Gregory L. Campbell the petitioner did appeal the decision of the Supreme Court of S.C by way of a Writ of Certiorari, which was denied; bringing the case to this Petition for rehearing.

In Conclusion the petition for a rehearing should be granted.





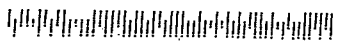
