AND NOW COME Respondents, Ronnie D. Dennis and Jeanette Dennis ("Respondents") with the consent of Petitioner, The Callawassie Island Members Club, Inc. ("Petitioner"), pursuant to Rule 263(b) and Rule 240 of the South Carolina Appellate Court Rules, and respectfully move the Supreme Court for an 18-day extension of time to serve and file Respondents' response brief, and for a 6-day extension for Petitioner to file its reply brief. Respondents respectfully submit that there is good cause for this extension, as follows:

1. The Court granted Petitioner's Petition for Writ of Certiorari by Order dated September 8, 2017.
2. Petitioners served their opening brief on October 24, 2017, having obtained a 15-day extension from the Court, with consent of Respondents.
3. Pursuant to Rule 242(i), SCACR, Respondents' brief is due to be filed on or before Monday, November 27, 2017 (the thirtieth day falls on Thanksgiving Day).
4. Respondents file this motion requesting an additional 18-day extension to file their brief and all accompanying materials. Respondents have obtained the written consent of counsel Barnwell Whaley for Petitioner to this request for an extension of time. Respondents have not previously requested an extension of time from this Court in this appeal.

5. The reasons for the request are (a) the length and complexity of the arguments in the Petitioner's opening brief, and (b) that counsel for Respondents have a number of large briefs due in other matters during November and early December.
6. Respondents have consulted with counsel of record for Petitioner, Barnwell Whaley, and such counsel consents to Respondents' request for an extension of time. If the extension is granted, Respondents' brief and accompanying materials would need to be served and filed on or before Friday, December 15, 2017.
7. Respondents also request that Petitioner be given a 6-day extension, until January 8, 2018, to file Petitioner's reply brief, so that Petitioner's brief is not due during the intervening holidays.

Therefore, for the foregoing reasons and with the consent of counsel for the Petitioner, Respondents respectfully asks this Court to (1) grant Respondents an extension of time to file their brief, to until December 15, 2017; and (2) grant Petitioner an extension of time to file their reply brief, to January 8, 2018.



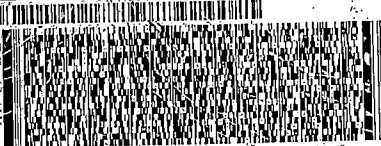

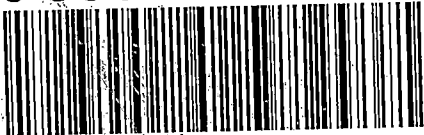
