Defendant - Appellant Wanda Gavin, moves this Court to grant permission to order late transcript and says in support thereof that:



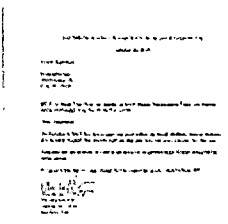

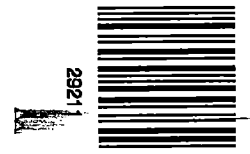
