I.

Cross; has submitted a Return to Petition for Writ of Certiorari in the South Carolina Supreme Court in State v. Habersham, State v. Haynes, and State v. Oates; has submitted an Initial Brief of Respondent to this Court in State v. Hall, State v. Alston, State v. Riden, State v. Smith, State v. Brown, State v. Graham, and State v. Hendrix; and has submitted a Petition for Rehearing to this Court in State v. Adkins.

III.

This extension request is not intended for purposes of delay, but rather to ensure that the Brief is properly researched and prepared. The Brief in the above case has required significant research because the case involves an important search and seizure issue on appeal. 

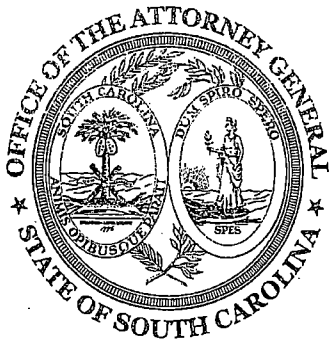
