As of one hour ago, we are in receipt of Respondents/Appellants' Return to Petition for Rehearing or Rehearing En Banc ("Return") in the above-referenced matter.

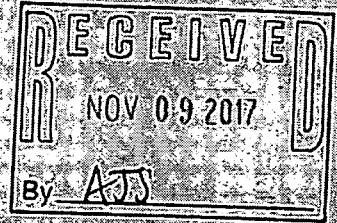
