

ORDER



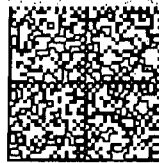
