

NOTICE OF APPEAL

Randall David Chandler appeals his guilty plea and sentence imposed by the Honorable Daniel D. Hall. On March 17, 2017, the Appellant pled guilty to Shoplifting with Property Crimes Enhancement (Indictment No. 2016-GS-46-02348) and Shoplifting with Property Crimes Enhancement (Indictment No. 2017-GS-46-01162). Judge Hall deferred the imposition of concurrent Ten (10) year sentences upon participation in the York County Drug Court Treatment program, from which Appellant was subsequently terminated in July 2017. On November 2, 2017, Judge Hall imposed the sentence of Ten (10) years with credit for time served of Three Hundred Eleven (311) days.



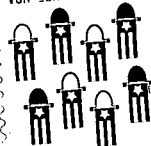
