

This letter is in response to the response letter from Christina Catoe Bigelow November 9, 2017 in which she alleges that Mr. Pencille filed two incorrect forms. Fact of the matter is I requested forms for as the title says "Inmate Trust Fund Account Report for South Carolina Court Filing Fees". General Counsel returned them highlighting the "I plan to file this action in the SC county of \_\_\_" part of the form in which I left blank as it was not applicable in this case. General Counsel then returned the form back to me with note attached stating I must fill in a county for this portion. I promptly filled in as best I could and returned to institutional mailbox. 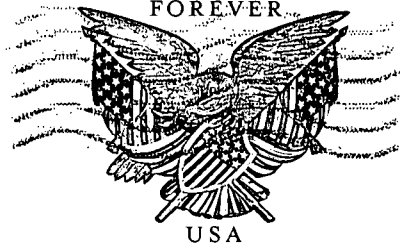
