DOMESTIC VIOLENCE OF A HIGH AND AGGRAVATED NATURE

That in Berkeley County, South Carolina, on or about March 27, 2017, the Defendant, Christopher Lee Holmes, did cause physical harm or injury to Elizabeth Burns, a household member, or did offer or attempt to cause physical harm or injury to said household member with apparent present ability under circumstances reasonably creating fear of imminent peril. That, in addition, the offense was committed, with or without an accompanying battery, under circumstances manifesting extreme indifference to the value of human life, which would reasonably cause a person to fear imminent great bodily injury or death.
