Dear Ms. Kitchings:

I am in receipt of your November 8, 2017, correspondence in which you requested a copy of the order of dismissal from the Workers' Compensation Commission. This is in regards to a prior letter from the Workers' Compensation Commission to Appellant Terry McCall informing Appellant his appeal would be dismissed if he did not submit the filing fee to process his request for appeal from the single commissioner's order within ten days.

On November 28, 2017, I spoke with General Counsel of the Workers' Compensation Commission, Keith Roberts, who informed that there is no formal order dismissing the appeal. Rather, under S.C. Code Reg. 67-702, the controlling regulation of the filing fee, the request for a filing fee is not complied with, the appeal automatically becomes dismissed. Indeed, the only evidence from the Commission of the dismissal is the eCase notation of the Notice of Appeal rejection dated March 29, 2016 and November 18, 2016 and the May 3, 2017, letter from the Commission (Eugenia Hollmon, Judicial Docketing Director) to Appellant confirming the appeal dismissal based on the failure to pay the filing fee. I have attached the eCase notations and letter for your review.

Please advise if there is anything further the Court may need. I have copied Mr. Roberts to this correspondence.

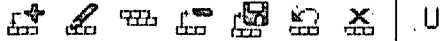

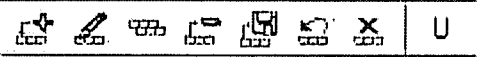
