

NOTICE OF APPEAL

Shawn Roseberry Bisnauth appeals his conviction and sentence in this case. On November 14, 2017, Mr. Bisnauth proceeded to trial before the Honorable Thomas L. Hughston, Jr. and a jury. The jury returned a verdict of guilty on November 16, 2017, and Judge Hughston imposed a sentence of three (3) years for the charge of Failure to Stop for Blue Light; a sentence of ten (10) years for the charge of Possession with Intent to Distribute Cocaine, 3rd Offense; a sentence of twenty five (25) years for the charge of Trafficking Methamphetamine, 3rd Offense; and a sentence of twenty five (25) years for Trafficking Heroin, 3rd Offense, all sentences to run concurrent. The undersigned counsel made a motion for a new trial and the Honorable Thomas L. Hughston, Jr. denied the undersigned counsel's motion for a new trial.





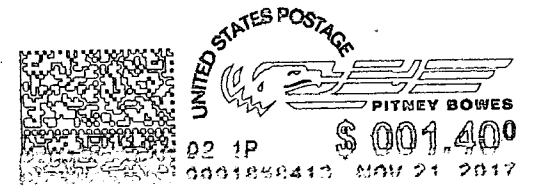
