Leaving the Scene of an Accident Resulting in Personal Injury (2017-GS-46-00469) and received one (1) year, consecutive. Possession of a Stolen Handgun (Indictment No: 2017-GS-46-00470) and received five (5) years, concurrent. Failure to Stop for a Blue Light (2017-GS-46-00471) and received twenty (20) years. Possession of Marijuana 2nd or Sub (2017-GS-46-00472) and received one (1) year, concurrent. Possession with Intent to Distribute Cocaine 2nd or Sub (2017-GS-46-00473) and received fifteen (15) years, concurrent. Resisting Arrest (Aggravated) (2017-GS-46-00474) and received ten (10) years, concurrent.





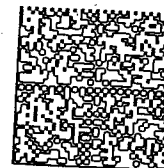
