TO RECONSIDER SENTENCE**



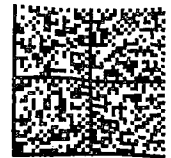
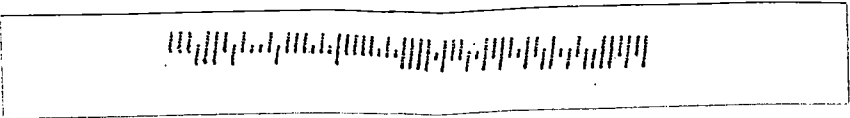
