We requested a transcript from Vivian H. Cross on September 28, 2017. On December 8, 2017 we sent a letter to Vivian Cross reiterating the request for the transcript. We are now in receipt of a letter from the Court of Appeals advising us to communicate with you regarding the fact that we have not received the requested transcript or a request for an extension from the court reporter.

Ms. Cross may have been confused by the fact that we filed an appeal in this matter on September 27, 2017 (Appellate Case No. 017-001985). 
