Ms. Kitchings:

My only concern is that I received oral argument notices for two other cases for February: State v. Filiberto Campos and State v. Michael Smith. I also have an argument in the Supreme Court on January 30.

I inherited Mr. Hamrick's case from John Strom, who left Appellate Defense, so I will be preparing for Hamrick from scratch and the Appendix is nearly 1000 pages. If all of three of these cases are argued within the same week, it will be very difficult for me to adequately prepare for Mr. Hamrick's case. If the Court could schedule Hamrick on 2/14, that would give me adequate time to prepare even if Campos and Smith are argued in early February.

I appreciate any consideration the Court is willing to give me on scheduling, but I will of course be there and be ready whenever the Court decides to hold the argument.
