


Request for Transcript of Record

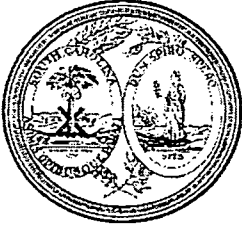

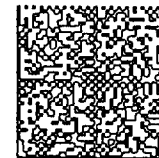

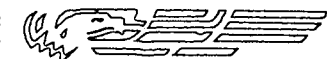
