MOTION FOR AN EXTENSION OF TIME

Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Curt Davis with the Court of Appeals on October 30, 2017. 
4. Counsel makes this request in good faith and not for purpose of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload

5. Counsel for the Attorney General's office consents to this request as shown by signature below.




