TION OF THE UNITED STATES SHALL BE SO ADVISED AND  
IF IT IS DETERMINED THAT THE PERSON IS FINANCIALLY  
unable to retain counsel THEN COUNSEL SHALL  
be PROVIDED UPON ORDER OF THE APPROPRIATE JUDGE  
UNLESS SUCH PERSON VOLUNTARILY AND INTELLIGENTLY  
WAIVES HIS RIGHT THERE TO.

(1) The defendant may be represented by an attorney.  
if the defendant cannot afford an attorney  
but wishes to retain one, counsel may be appointed  
for him (see DEFENSE OF INDIGENTS RULE 602
